## GENERAL CONDITIONS (please read carefully before registration)

#### 1.

The language school is responsible for the accurate processing of courses and reservation of your accommodation. This does not include any offers from any third-party.

## 2. Enrolment

If you want to participate in one of our courses, please use the application form. If you would like to get further information or have any questions concerning your enrollment, please do not hesitate to contact us. Once your booking has been confirmed, you may be requested to pay in advance. Payment can be made by bank transfer. The remaining costs are taken on arrival in cash or by credit or debit card.

## 3. Days without teaching

There is no teaching taking place on the following days: 01.01., 06.01., 25.04., 01.05., 15.08., 01.11., 08.12., 24.12., 25.12. **The lessons will be partly given on other days.** Please contact us for more information.

## 4. Lessons

One lesson of teaching lasts 55 minutes.

## 5.

The Minimum age for general Italian courses is 16. There is no upper age limit.

#### 6.

When necessary, the school reserves the right to alter the timetable and/or transfer students from one class to another.

## 7. Accommodation

Accommodation may only be used by those who booked it; guests must <u>sign up</u>. It is not allowed to use the accommodation for unusual purposes, the cost of any damage the student or visitors cause will <u>be deducted</u>. Every participant is committed to leaving the rooms in good and clean condition.

### 9. Arrival

#### 10. Placement and starting day

The assessment test will take place on the first day of teaching. (Monday 9 a.m. at the school). Lessons will start immediately after the test.

The accommodation is valid only for the person and dates specified. Any changes to the dates must be sent to us in writing or by email at least 2 weeks before the arrival date.

## 12. Attendance

You are expected to attend all classes. Failure to do so may result in changes to the final certificate you shall receive as proof of study (which is important for university credits).

## 14. Cancellation and changes
